## 2009 in Review

### Park Improvements

In 2009, ten projects to improve the facilities at three Third Ward parks were completed with another nine in progress.

#### Fuller Park (331 W. 45th)

Fuller Park received renovations to their fountain, veranda, tennis courts, and walkway. They also received a brand new fitness center and playground, improvements to their field house such as new air conditioning and a new roof, and a new roof for their powerhouse. Projects in progress are the replacement of the auditorium floor, energy efficient updates to the boiler and heating system, structural improvements to the field house,

HVAC energy management system, a pool accessibility lift, a new elevator, and the replacement of the gym floor.

**Robert Taylor Park (41 W. 47th)**

A pool accessibility lift has been installed, the restoration of the gym floor is in pre-design, and the replacement of the roof is currently being contracted out.

**Lowe Park (5203 S. Lowe)**

The rehabilitation of the basketball court for Lowe Park was completed.

**Friends of the Park Award**

Last February, Alderman Dowell was honored to receive a legislative award from Friends of the Park. The award was in recognition of the \$3 million in TIF funds she secured to restore historic Fuller Park.

**New Park at Federal and 24th**

A new park located near the Harold Ickes public housing site opened September 28, 2009. This park has a new playground, walking path, and baseball diamond.

## **Education**

2009 was a year in which Chicago Public Schools received a great deal of national attention. This was partly due to President Obama's appointment of former CPS CEO Arne Duncan to the post of Secretary of Education. Unfortunately, the greatest amount of attention was received after the tragic death of Derrion Albert. As Chicagoans, we know this was not an isolated incident and that we must continue working together to improve school safety and performance.

**Third Annual Back to School Extravaganza**

Last August, Alderman Dowell held her Third Annual Back to School Extravaganza at Fuller Park. As in years past, we had a great turnout and several wonderful volunteers and donations that made the event a success. This year, we distributed over 500 backpacks filled with school supplies. This year, we were fortunate to utilize the Olympic theme and were honored with a visit from 1968 Olympic Long Jump world record holder, Bob Beamon.

**Capital Improvements**

Even with modest improvements in the economy, obtaining capital improvements still requires a great deal of effort as we relay the concerns of principals, teachers, and parents to officials at Chicago Public Schools who are working with limited budgets. Fortunately, many of the requests we have made to the CPS Office of Facilities have been granted or are still being considered. Currently, there are 10 capital projects in progress with a combined total of almost \$33 million. Major boiler and mechanical system renovations for ACE Tech, Beasley, Bronzeville Lighthouse, Woodson South, and Mayo Elementary are underway with HVAC work to begin at John Hope High School this year. ADA related construction scheduled for completion this year includes Woodson South, Mollison, Perspectives IIT, and Attucks schools. Beasley, DuSable, John Hope, and Phillips schools will be receiving renovations to their swimming pools. A new playground has also been installed at Mollison. We realize there are a lot of unfunded needs that still need to be met, but this is a good start towards making sure our students have the best learning environment possible.

**High School Safety Task Force**

Established in July, 2009, this was created as a result of the Third Ward Office working with Mike Shields from CPS' Office of Safety and Security. It is an informational and resource exchange between principals, CPS, CTA, and Chicago Police Officials, and representatives from various non-profit organizations and neighboring wards. Members from Alderman Dowell's staff have also been attending safety task forces and LSC meetings from various schools in the 3rd Ward.

**Principal's Breakfast Meetings**

Periodically throughout the academic year, Alderman Dowell hosts these meetings as a means of hearing the needs and concerns of the schools in the Third Ward and notifying the principals about various resources that may be available to them. The last meeting in October was an opportunity for the new Chief Area Officers (formerly Area Instructional Officers or AIOS) to introduce themselves and explain their role. Additionally,

Jaime Guzman, the new Director of the Office of New Schools was there to describe his role and Kye-Anne Wilborn from the Education to Careers Program described how schools can utilize the skills of CPS students to obtain a variety of services from procurement of safety horses and trophy cases to catering services.

### **Columbia College's New Media Production Center**

Opening in February, 2010, this state-of-the-art facility will provide college students with expanded opportunities to learn about media production and advance in their academic and professional careers. The one-story Media Production Center will include two sound stages, a motion capture studio and an animation lab, among other amenities, for film, video and television majors. Located in the Third Ward at 1600-1632 S. State St., the construction of this facility provided jobs to several Third Ward residents. Alderman Dowell approved the sale of the city-owned parcel of land needed to construct the new media center.

## **Infrastructure**

### **Department of Water and Sewer Management**

The Department of Water Management completed several water main projects throughout the city. In the Third Ward, they completed a new water main project along South Union between West 51st and 53rd Streets, replaced the 120 year old pipes along East Oakwood Blvd. between S. King Dr. and S. Vincennes and on Vincennes between 43rd and 47th, installed new, larger pipes along West 48th St. between South Racine and South Morgan, installed a new water main on S. Indiana between 45th and 48th Streets, rehabbed the sewer lines on W. 26th between Federal and State, installed a new water main, pressure tested the pipes, and did sewer repair work.

### **CDOT**

Pavement repairs were made to 47th Street between Shields and Normal, 35th Street was resurfaced between Federal and LaSalle, and completed a street and driveway improvement project at 47th and Shields to address the disrepair underneath the viaduct. As part of the City's Arterial Street Resurfacing Program, the following streets will be resurfaced in the Spring of 2010: State St. from W. Congress Pkwy. to W. 18th, Cermak from S. King to S. Clark, Halsted from W. Garfield to W. 59th St., and State St. from W. 47th to W. 79th. New sidewalks were installed on S. Laflin from 45th to 47th, on the 4400 block of King Dr., on the 5700 block of S. Lafayette, the 300 block of W. 42nd Pl., the 3200 and 4200 blocks of S. Michigan, the 4200 block of S. Wabash, the 4600 block of King Dr., and the 5100 block of S. Halsted. Over 100 new signs were installed, which included "No Parking", "Safe School Zone", and "One-Way". New alleys were installed at East 38th and 39th Streets between Wabash and State that utilized new drainage and green alley techniques.

### **Streets and Sanitation**

The Bureau of Electricity has completed the upgrading of street lights on the 3700 block of South Calumet, the 4200-4500 blocks of South Princeton and the 5200 block of South Green.

### **Root Street Bridge**

In November, construction work for the rehabilitation of the 320-foot Root Street Bridge was completed after a year long process that involved several state and city agencies. The \$5.5 million project marks the first major reconstruction since the viaduct was built in 1961 and involved resurfacing, installation of storm sewers and drainage structures, and lighting replacement. Albin Carlson and Co. had neglected to implement a process in which local residents and minorities could be hired to do the work. Alderman Dowell organized a protest that took place on March 28th. About 20 residents joined her including students from Dawson Technical Institute's Dawson Skill Center and members of the United Services of Chicago. As a result, one person was hired on the spot and Albin Carlson worked with community stakeholders to develop a hiring policy that put 3rd Ward residents first.

### **Metropolis Shopping Center**

On July 16th, the Chicago Plan Commission approved a zoning change that will allow for the development of the Metropolis Shopping Center at 39th and State. The anchor of this shopping center will be the 60,000 square foot Roundy's Supermarket which will provide needed fresh food options for people in the community. We are working to attract other future tenants including a bank, a performing arts center, and a drug store that will provide needed resources for the community. Alderman Dowell was also successful in her request to City Council and Mayor Daley to use \$28 million of Chicago's \$332 million in Recovery Zone bonds from the federal stimulus money to construct the major retail complex.

## **Landmark Designations**

In recognition of the historical importance of the Calumet-Giles District, the Committee on Historical Landmark Preservation convened on July 27th where Alderman Dowell recommended and subsequently received the support of the committee for the designation of the following areas as a Chicago Landmark:

3112-3443 S. Giles Ave, 3735-3849 S. Giles (odds), 3800-3849 S. Calumet, and 300-319 E. 38th St.

The Margaret Burroughs Home at 3806 S. Michigan, Metropolitan Apostolic Church at 4100 S. King Dr., and the Chicago Baptist Institute at 5120 S. King Dr. were also land marked in 2009.

## **Other Infrastructure Related Actions**

Alderman Dowell approved the sale of city-owned land to a dozen Third Ward residents through the Adjacent Neighbors Land Acquisition Program and supported the rehabilitation of Dearborn Homes.

Additionally, 2009 saw the demolition of 6 of the 11 buildings at the Ickes Public Housing site, which will be replaced by mixed-income housing units.

Alderman Dowell worked with members of The Renaissance Collaborative, which hired Third Ward residents to do a corridor cleaning program which included: 35th, 39th, 43rd, 47th, 51st, and Halsted Streets. This work will continue in 2010 and is funded by 3rd Ward TIF money.

## **Legislative**

January, 2009 - Alderman Dowell introduced an Ordinance to City Council that exempts some parking meters near helping institutions in the 3rd ward only from Sunday hours and will ensure that all new meters in the ward (placed in 2008 only) will be exempt from the new rates for at least two years.

February 2009 - Alderman Dowell along with Aldermen Flores and Waguespack co-sponsored an Ordinance that would require all information related to all of the 160 TIFs in Chicago including every specific agreement, amendment, attachment, order, audit, and record for every use of money to be published on a user-friendly website.

Alderman Dowell introduced a Resolution that would require Chicago Public Schools, the Chicago Departments of Transportation and Streets and Sanitation, and other city departments that receive federal economic stimulus money to present the details of their proposed projects to the City Council and submit a process in which they will send and receive input from elected officials and community members. The Resolution was passed with the signatures of nearly every City Council member and a public hearing.

March, 2009- Alderman Dowell along with with Aldermen Preckwinkle, Cochran, Fioretti, and Hairston co-sponsored the Chicago 2016 Memorandum of Understanding which was largely shaped by the 3rd Ward 2016 Olympic Committee. The MOU was designed to ensure that the affected communities would have their interests and rights protected. The MOU included: opportunities for minority, veteran, disabled, and women owned businesses, protection of property rights, and requirements for construction, local investment, and affordable housing. Additionally, the MOU called for a Resolution to be adopted by City Council to support the objectives outlined in the MOU.

April, 2009- Alderman Dowell made use of legislation that holds liquor dealers accountable to the communities where they operate. Pursuant to Chicago's Municipal Code 4-60-195, the Third Ward office has received numerous complaints regarding public nuisances caused by various liquor dealers in the 3rd Ward. Currently, Calumet Food and Liquors is in the last stage where all public hearings have convened. It is now up to the residents within 500 feet of the establishment to sign a petition that is being circulated by Third Ward Office volunteers. If a majority of residents within 500 feet do not sign the petition, Calumet Food and Liquors will continuing doing business as usual.

May, 2009- Alderman Dowell introduced legislation that allow homeowners to access Tax Increment Financing (TIF) funds through the Neighborhood Improvement Funds (NIFs). The NIF grants can be used for exterior improvements that restore the integrity of the property and safety and health upgrades such as heating, plumbing, and electrical work. In 2009, two areas were targeted: the Pershing/King TIF and the 47th/Halsted TIF. In 2010, two new areas will be identified.

June, 2009- Alderman Dowell, along with Aldermen Flores, Reilly, and Mell co-sponsored an ordinance that requires a report detailing the terms of any proposed city asset sale or lease agreements before the bidding process, a minimum 60-day review period to allow the City Council to properly assess and analyze the terms of the agreements and hold public hearings, and an independent auditor such as the Office of Inspector General to serve as an independent analyst.

July, 2009 - In light of the recent budget shortfalls, Alderman Dowell was the lead sponsor for an ordinance that would require the Mayor to provide City Council with a proposed budget for the next year at least one month prior to the first scheduled budget hearing. All documentation shall also be posted on the City's website within seven days of their release. The ordinance has yet to be passed as it is still in the Budget Committee.

## **Troubled Buildings**

The Third Ward staff developed working and productive relationships with troubled building officers from our police districts and helped facilitate meetings between the Department of Buildings and the Chicago Police to develop more comprehensive strategies. To the extent possible, the Department of Buildings will be focusing on "hot spots" to secure or demolish several buildings within a troubled area. In 2009, 16 troubled buildings in the Third Ward were demolished. These include: three on the the 5500-5600 blocks of S. Perry and four on the 3900-5000 blocks of S. Wells. In addition to the 16 buildings that have already been razed, two properties on the 5500 block of S. Lafayette are being expedited for demolition.

## **Public Participation**

In addition to attending CAPS meetings, Alderman Dowell has organized several events designed to garner community input on a variety of issues. In 2009, she held two Town Hall Meetings covering topics including development and weatherization. She also held a Safety and Security Seminar in which the Chicago Police and several organizations provided useful tips for residents to keep their homes and neighborhoods safe. Last July, about 100 area residents, business owners, and developers gathered to discuss the redevelopment of Garfield Boulevard. Alderman Dowell required the participation of the University of Chicago so they could explain how their development plans are synonymous with the goals of the community. Three community meetings regarding Garfield Boulevard development were held from July to December.

Additionally, Alderman Dowell conducted a property tax appeal seminar in which residents were able to receive assistance from the Chicago Tax Assistance Center in appealing their latest property tax assessments as well as workshops for home foreclosure prevention and condo ownership.

In an effort to maximize the level of community input and distribution of resources to neighborhoods, Alderman Dowell established a network of Community Block Club Captains. We were pleased to have over 30 community members volunteer for this position.



## **Current Third Ward Update**

### **Education**

#### **School Safety Patrol Training**

In December, 2009, Alderman Dowell hosted a training session for community members who want to become involved in school safety efforts. It was attended by representatives from multiple Third Ward schools and was very informative. #### **South Loop School Possibly Moving into The National Teacher's Academy**

In an effort to address overcrowding issues at the South Loop Regional Gifted

Center, CPS has crafted a proposal to move the 6-8 grades to the National Teacher's Academy building. Initially, the Local School Council for the South Loop School unanimously supported the move for the 2010-11 school year, but after hearing testimony from various members of the community, it became clear that there were a lot of unanswered questions regarding enrollment, resource allocation, and attendance boundaries. Additionally, many people were disturbed to learn that the principal and administrators from the National Teacher's Academy had not been included in the process. The latest vote from the South Loop's LSC did not support the current plan put forth by CPS. Alderman Dowell is demanding more time for community involvement and will continue to work with Alderman Fioretti, CPS, and NTA to ensure that there are not two unequal schools in the same building and that every child on that campus has the same access to a quality education, extra-curricular opportunities, and college resources. CPS will make its final decision in the coming weeks.

### **CPS' Magnet and Selective Enrollment Policies**

Despite protests from minority groups and elected officials including Aldermen Pat Dowell (3rd Ward), Anthony Beale (9th Ward), Freddrenna Lyle (6th Ward), as well as State Representatives Will Burns (26th District), Barbara Lynn Currie (25th District), and State Senator Kwame Raoul (13th District), CPS and the Chicago Board of Education have made changes to their enrollment policies regarding Magnet and Selective Enrollment schools. The changes place no limit on sibling enrollment, will draw up to 50% from a proximity-based lottery and then split the remaining seats between four different socio-economic tracts from throughout the city. The decision came on the heel of a federal judge's lifting of a twenty-eight year old consent decree that forced CPS into making more efforts to desegregate their schools. The judge determined that race could still be used as an enrollment factor, but could not be the only factor. CPS and the Board of Education claim that using socio-economic status instead of race will increase diversity at magnet and selective enrollment schools. Alderman Dowell wrote a letter to the Chicago Board of Education, which was read at the last BOE meeting in December. In it, she pointed out how the new policy will create less diversity along both racial and socio-economic lines and cited a preliminary study that validated her concerns. The enrollment policies are to be tested this year and CPS has made a commitment to make adjustments based on efficacy and community input. As such, we will continue to work with CPS to ensure Third Ward children have equal access to magnet and selective enrollment schools.

### **Schools**

The Chicago Department of Transportation will be surveying the areas around several Third Ward schools to determine if there are ways they could influence the flow of traffic to improve school safety for both children and parents.

### **37th and Michigan Sidewalk and Parkway Restoration**

CDOT has completed the sidewalk and parkway restoration project at 37th and Michigan, which was funded by the Bronzeville [Tax Increment Financing](#) (TIF) District.

### **LED Traffic Signal Updates**

With the use of stimulus money, the incandescent halogen light bulbs in many traffic signals are being replaced with light emitting diodes (LEDs) throughout the United States. LEDs are advantageous because they are brighter and use less energy. They also last a lot longer than halogen bulbs which means less time and money spent and less traffic blockage from the work crews who change the bulbs. In the Third Ward, 17 traffic signals will be updated in 2010. They are located at the intersections along Pershing Rd. at Indiana, LaSalle, State, Wabash, and Wentworth as well as the intersections along S. Michigan Ave. at 33rd, 35th, 37th, 41st, 43rd, 45th, 47th, 49th, 51st, 53rd, Garfield, and Pershing.

### **Post Office on South Bishop to Remain Open**

In response to constituent concerns and a petition, Alderman Dowell wrote a letter to the District Manager from the United States Postal Service to request that the Post Office at 4642 S. Bishop remain open. As a

result, this location will remain open and maintain all of its current services.

### **National Association of Letter Carriers Receives Architectural Award**

The Association of Licensed Architects recently awarded the National Association of Letter Carriers an Award of Merit in recognition of superior achievement and professional design excellence for the NALC building located at 39th and Wabash. Congratulations NALC. We are glad to have you in the Third Ward.

### **Alley Construction and Closure on Cullerton**

Due to sewer excavation, the alley from Cullerton St. north to the Sedgwick Properties construction trailer will be closed from Monday, January 4th, 2009 to Friday, January 15th, 2009. The closure will affect access to the alley at the following buildings: Second Presbyterian Church, the condo building at 1910 S. Michigan, the condo building at 1918 S. Michigan, The History Makers, Commercial Business Building, the condo building at 1844 S Wabash, the condo building at 1826 to 1830 S Wabash, the condo building at 1808 S Wabash, The Studios, National Exterminating Supply, Ada S McKinley Community Services Inc. ## **Affordable Housing**

### **Legends South Phase A2**

Legends South Phase A2 is part of the CHA Plan for Transformation. The 138 unit, \$45 million mixed-income project will be built on land formerly occupied by the Robert Taylor Homes along the 4300-4500 blocks of South State and South Federal. The project will provide 60 units of CHA replacement housing, 50 affordable rate units for renters not exceeding 60% of the [area median income](#), and 28 market-rate units. This development will incorporate green design elements including Energy Star insulation, energy efficient windows and appliances, sustainable landscaping, and bio-swales to collect drainage water from the roof and disconnected downspouts.

### **The Renaissance Collaborative's Senior Village**

This 71 unit, \$5 million affordable senior housing project will provide housing for seniors who are at or under 60% of the area median income. \$2,382,000 came from [Low Income Housing Tax Credits](#), \$1.9 million came from the Department of Community Development's [Multi-Family Loans](#), and \$725,000 was financed through the Washington Park [Tax Increment Finance](#) (TIF) District.

### **Chicago Low-Income Housing Trust Fund**

Nineteen rental properties managed by thirteen different companies in the Third Ward received a total of \$595,314 in annual subsidies to help renters meet their housing needs. To learn more about the Chicago Low-Income Trust Fund, click [here](#).

### **Neighborhood Lending Program**

## Events and Services In And Around the Third Ward

### Community Arts Assistance Program Application Assistance Workshop



The Community Arts Assistance Program (CAAP) was created in 1987 through funding provided by the Illinois Arts Council Access Program. The goals of CAAP are to discover, nurture and expand Chicago's multi-ethnic artists and nonprofit arts organizations; and to foster new and emerging individual artists and arts groups by providing grants for professional, artistic, and organizational development to those who have had limited access to funding in both public and private grants programs. CAAP grants provide financial assistance to individual artists, and to nonprofit arts organizations with incomes under \$150,000. The maximum grant request is \$1,000. Funding priority is intended for applicants who have not been previously funded through the CAAP Program, or have not had access to traditional funding programs such as grants, fellowships and art commissions from the National Endowment for the Arts, Illinois Arts Council, corporations, or foundations. It is strongly recommended that first time applicants attend an application workshop. The workshop closest to the Third Ward is listed below. ### **nextSTEP Business Bootcamp**

### **City of Chicago Property Tax Relief Program**

This program is meant to provide relief between \$25 and \$200 to City homeowners hit hardest by increases to their 2008 property tax bill for their primary residence. This program is needed largely because of the phase-out of the state law that put a 7 percent cap on the annual increase in the taxable value of home property, and because the drop of this year's exemption under that law went to \$20,000 from \$26,000. The amount of tax relief you might receive is based on a combination of income level and the amount of your property tax increase. ### **47th/Halsted Tax Increment Financing Neighborhood Improvement Funds (TIF/NIP) Are Now Available**

Last May, Alderman Dowell introduced legislation that allows homeowners to access TIF funds for exterior improvements like roof repair, gutters, down spouts, siding, masonry work, tuck pointing, new windows, doors, and porches, painting, concrete work, exterior lighting, and wrought iron fencing. Up to 30% of the funds may also be used for safety and health upgrades such as heating, plumbing, and electrical work. The TIF/NIP Program provides grants for single-family residential properties and is open to eligible owner-occupants of a one-to-four unit residential properties within the 47th/Halsted TIF District. Although parking meter rates will be increasing significantly throughout the city, the parking meters in the parts of the Third Ward will be adjusted according to the ordinances introduced by Alderman Dowell and passed through the City Council. These ordinances mean rates for existing meters that are in close proximity to churches and new meters installed on commercial corridors like 35th, 47th, and Ashland will remain significantly less than the Citywide rate, even after the latest rate increase.
